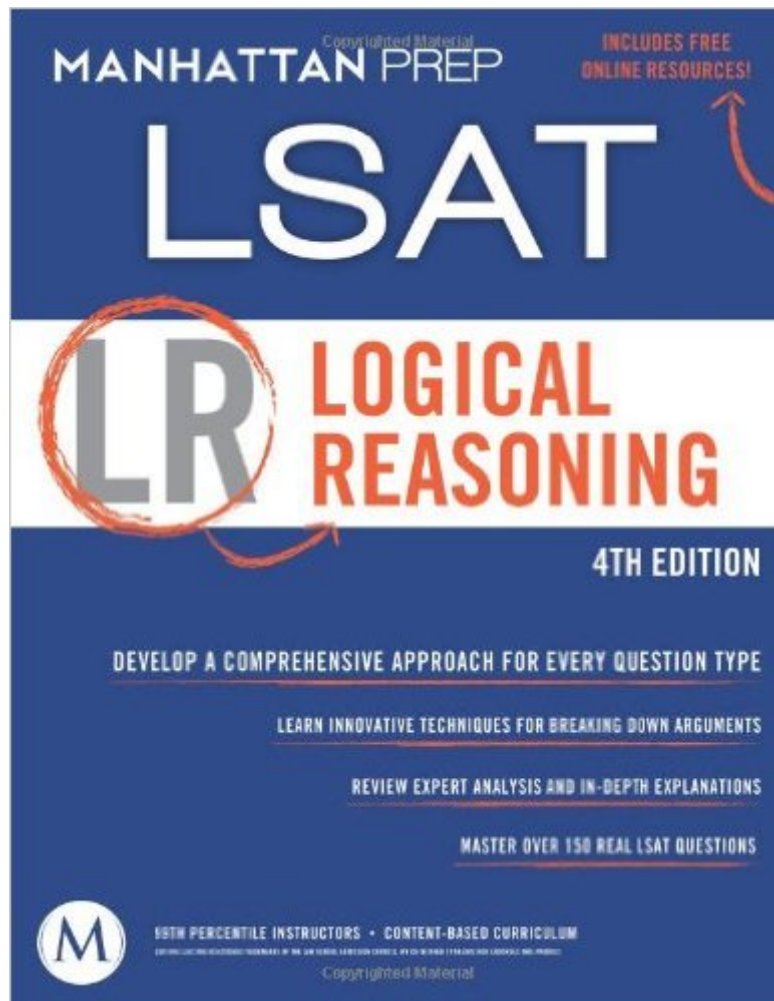

The most underrated logical reasoning prep-book. Teaches you how to think for this section and questions are put into 4 main categories, making it much more streamlined than the popular Powerscore book.

They say "oh purchase the original because you won't be able to register the book to get the online help" The online assistance is garbage and this book is not that simple; buy the cheapest used one & don't waste your money buying original.
