

Each of the 4 1/2" by 2 3/4" flash cards is designed with a punch hole in one corner. The hole accommodates a metal key-ring-style card holder enclosed with the set. Using the holder, students can arrange the flash cards in any sequence that suits their study needs.

I love these flash cards. There are SO many of them with so much information and I absolutely love it. Of course, this material is in the books but to have it at your fingertips, arranged in such a way that helps to maintain the knowledge and continue to learn and absorb additional useful information-its awesome. These are a concise set of flashcards to help with law study of the first year topics. The cards are arranged and coded by section (contracts, torts, criminal) so it is easier to pick the ones you wish to study. The cards have a hole in one corner and there is also a round metal ring included for carrying the cards outside of their storage box, although I don't think I will use that option.

I bought this to help me study and I never used it. Its good for what it is (i.e. a commercial first year study aid) but you are better off dedicating your time to making your own notecards or practicing writing old tests. I gave it five stars since there is nothing wrong with the product itself, but you just need to use it as a supplement, not as your primary study method.

I found these flashcards to be extremely helpful because I didn't have to make the notecards myself which saved me a lot of time to study. The notecards are accurate and concise. Highly recommend.

The 1L flash cards are good method of studying the rules of law. It contains information on Contracts, Criminal Law and Torts and the citation of one or more cases as examples of that rule of law. I seem to not be a user of flash cards and learn more through books with hypothetical cases/situations, multiple choice answers and then an explanation of why each answer was right or wrong. The flash cards can be a method of quick review for exams.

I made my own and I also got kaplan MBE flash card app on my iphone. Wayyyyyy better then these. These cards are overly complicated for flash cards - I did not find them useful.
