

This is a good review of basic estimating with very usable check lists. The experienced estimator will find it very elementary, but it does allow you to rethink some practices. It could be good for someone in management that does not have knowledge of estimating.

The title represents itself as an industry standard, even though it does not state what industry. The intended industry is construction cost estimating. However, the content may only apply to preparing bids for general building construction projects. The second paragraph admonishes estimators that they should not bend to pressure to "make expedient short-term decisions that can result in an unsound bid." (6th ed.) There is undue focus on "ethical and moral precepts" loosely defined by the

American Society of Professional Estimators (ASPE). There is coverage of bid day procedures and condemnation of bid peddling. Okay, I get it, they don't like bid peddling and they declare it to be unethical. But only estimators involved in preparing bids where work will be subcontracted have any reason to be involved with subcontract bidding. There are many other estimators. Should the publication be renamed to "Standard Handbook of Moral Bid Preparation?"There is some valuable content on specific discipline estimating practice, which budding estimators can learn from. But it is not an industry standard, in my opinion.
